Enhancing Educational Resources:

Your contributions directly fund essential learning tools, including:

- Modern textbooks and learning materials
- Advanced educational technology
- Classroom supplies that support effective learning
- Expanded access to online resources

Upgrading Facilities and Maintaining Our Grounds:

Your financial support enables us to:

- Make vital improvements to school buildings and grounds, ensuring a safe and welcoming environment for all
- Employ maintenance staff and a gardener to maintain and enhance our outdoor spaces.

Technological Advancements:

Without additional contributions, we face the risk of limiting our students' access to essential technology, such as:

- No Individual Devices for Year 3- Year 6: Without sufficient funding, we won't be able to provide individual devices for these students, forcing them to share devices with lower-year levels
- Delays in Upgrading Technology: Planned investments in SMART screens, laptops, and other vital tools may be postponed or even cancelled
- Reduced Device Access for Year 1 and 2: We will be unable to expand the number of devices for these younger students, leading to increased sharing and less hands-on learning
- Limited Charging and Storage Solutions: The acquisition of new device trolleys for storage and charging will be delayed, making it harder to manage existing resources.
- Slower Progress on Technology Infrastructure Enhancements: Without sufficient contributions, necessary upgrades to our technology infrastructure may be stalled, impacting the quality of teaching and learning.

In summary, paying fees and voluntary contributions to a school directly benefit students by improving their educational experience and it allows schools to provide better resources, facilities, and support systems, ultimately improving the quality of education students receive.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
